 - Ryan Building Team Another estimate for the roof damage to the entire west side of the roof. Old plastic drip edges along all roof edges need to be replaced. \$16000 for fixing the roof. \$10,000 set aside for fixing the roof. Suggest that we work with the property budget but dip into the emergency budget. Approx. \$9000 is still sitting in escrow with the city of Fort Collins that needs to be given back to us. This could be put towards the roof fix. There is 60K in the emergency fund. This is not a long term fix for the roof. This would just be a patch job to get through the next 5-10 years. Looking at a possible capital campaign in the future to fund a new roof.
